

SWORN STATEMENT

I, the undersigned **MILOSH POTISKA**, Czech Passport Number 40064026 state under oath in English (the contents hereof having been fully interpreted to me in Czech by a qualified Interpreter Mrs Eva Motyckova in Prague) as follows:

1

I make this statement freely, voluntarily and without any undue influence in accordance with section 204 of the Act. Further, insofar as it may be necessary, subject to the provisions of section 105A of the Act; having been informed that my statement may incriminate me in various offences and notwithstanding the aforesaid, I may be called as a witness on behalf of the prosecution and further be required to answer questions which may incriminate me. However, if in the opinion of the court, I am found to have answered all questions frankly and honestly I will be discharged from prosecution on such charges or any competent verdict thereon. Further that the contents hereof may not be utilised in any manner or be regarded as admissible evidence in any trial against me.

I am a Czech citizen and am currently living in Prague. I was during the period of September 2010 until 2012-02-03 living in South Africa and during that period I was working for Radovan Krejcir ('Krejcir'). I left South Africa, because I could see that Krejcir was getting involved in so much criminal activity that, sooner or later, I would be dragged into it and even possibly murdered, like so many of his other 'associates'. As a consequence of my working for Krejcir, I had intimate knowledge of some of his criminal dealings. Krejcir would communicate with me directly face to face, or via telephone from his phone on number 071 700 0000 to my phone, I had many telephone numbers but I cannot now remember what they were.

I had been in South Africa only a few months, and had realised who this Krejcir person was in South Africa. I knew him from the Czech Republic, but he wasn't such a big shot there, not like the big psychopath he became in South Africa. I soon realised he was a dangerous man and would kill everyone who crossed him. Krejcir would make many deals with people but would not give them their money back and would threaten to kill them or even have them killed. There are many people who he wanted to kill in South Africa, he told me who they are. Some of them are already dead.

This statement outlines the sequence of events when I was asked by Krejcir to kill Paul O'Sullivan ('O'Sullivan').

Krejcir asked me at least 3 times to kill O'Sullivan. When I arrived in South Africa in 2010, Krejcir told me that O'Sullivan was a *'thorn in his side,'* or, to put it another way, was *'a pain in the arse.'* Krejcir went on to say, *'the fucking Irish, blah-blah-blah, I hate him, he made me lots of troubles, he is a fucking mother fucker, you must sort him out, you know blah-blah blah!'* From the words 'sort him out' I knew Krejcir wanted me to kill O'Sullivan, or to have him killed.

Krejcir asked me at least 3 (three) times if I could arrange for people from the Czech Republic to kill O'Sullivan. I told him *'no,'* as I didn't want any part in anyone being killed. I also didn't want any attention as Lolly Jackson had recently been killed at that time. But Krejcir was very insistent one time, and would not leave the matter. This was soon after Cyril Beeka died, and Krejcir was arrested.

Krejcir seriously wanted O'Sullivan killed at this time. This was in or about April 2011. Krejcir said that he would give me a big gun and I could get a sniper to kill O'Sullivan.

Krejcir told me O'Sullivan had an office somewhere near Melrose Arch in Johannesburg. Krejcir said that there was parking under the building, and that is where O'Sullivan parked his car. Krejcir said that I must arrange people from the Eastern Block and place bombs in O'Sullivan's car. Krejcir wanted me to do this job quickly. I asked him why he was in such a rush to have O'Sullivan killed. Krejcir also told me that if I could not get to O'Sullivan's car at work, with bombs I must follow O'Sullivan from work on a motorbike and bomb his car when it stops at a robot, or shoot him through the window.

Krejcir had many ideas on how to kill O'Sullivan. He even asked me if I knew anything about remote controlled helicopters or drones. He wanted me to land the helicopter, which had a bomb on it, near O'Sullivan and then via a cell phone call to O'Sullivan cause the bomb to detonate and explode, thus killing O'Sullivan. Krejcir also wanted camera footage of this attack. I think he may have been watching too much TV at the time when he came up with these ideas.

Prior to me signing this statement, I have carefully read through it and am satisfied that the facts are correctly and accurately recorded. The following questions were put to me in person by the commissioner of oaths and I entered the answers thereto in my own handwriting:

'Do you know and understand the contents of this statement?'

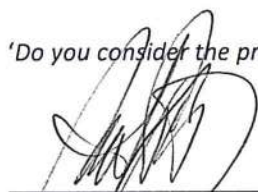
