I wish to state as follows:-

I am one of the Investigating officers of the South African Police Service National Task Team mandated to investigate the University of Fort Hare (UFH) Murders, Attempted Murders and Fraud and corruption cases. When the team arrived in Eastern Cape in January 2023, we were introduced to Mr. Isaac Plaatjies the Director of Vetting, Investigation and Protection Services. Mr. Isaac Plaatjies was assisting the team. I got to know him.

I do not remember the date and time, but I was in his office Church Street, UFH Library Combined Building, Fourth Floor, East London when he told me that his wife sells the clothes that are sold in retail clothing shops like Woolworth and Truworths. He offered to give me some of the clothes that his wife is selling as a gift and said I don't have to pay for them.

On Thursday, 12th of October 2023 in the morning I received a WhatsApp phone call from Isaac Plaatjies number: 072 472 1029, he informed me that he was not feeling well, and he wanted to give me a coat and a polo-neck. I told him that on that day I was going home. Isaac Plaatjies then told me that he will send one of the undercover guy that works for UFH under him to bring the above-mentioned items. On the same date at about 13:10 I phoned Isaac Plaatjies, and I informed him that I was leaving for KwaZulu-Natal, and he told me that I will meet with the undercover guy and asked me where I can meet him. I told Isaac Plaatjies that I will meet the said undercover investigator at Engen Filling Station Garage, Abbotsford. Isaac Plaatjies told me that his guy will be driving a white Nissan np200 bakkie. I also told Isaac Plaatjies that I was a white Toyota Corolla with registration number: **NH14948**.

On the same date at about 13:33 I arrived at Engen Garage, Abbotsford I parked inside the garage premises and at about 13:38 an African male arrived driving a white Nissan np200 bakkie with no canopy and he parked parallel with my vehicle he alighted from his vehicle he was speaking on his phone. After dropping the call he came to my vehicle, my window was opened he greeted me, and he gave a white plastic upon inspecting the plastic there was a maroon coat and a green polo-neck and he left.

Isaac Plaatjies phoned me using WhatsApp call and asked me if his guy came, I told him yes and I thanked him for the said items he gave me. I further state that the said African who was sent by Isaac Plaatjies did not tell me his name and nor I told him my name. Accasius Smitla MOKOENA, further states under oath in English: -

I consider the prescribed oath binding on my conscience.

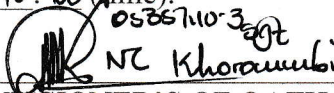
