1. PURPOSE OF SUBMISSION

- 1.1. The National Police Agency of Japan is inviting members from the South African Police Service, Division: Crime Intelligence, Republic of South Africa to attend the Twenty-sixth Asia Pacific Operational Drug Enforcement Conference on 30 January 2024 and 31 January 2024.
- 1.2 The application is to obtain authorization for the Component Head: Intelligence Analysis and Coordination, Major General NP Madondo and Acting Component Head: Intelligence Collection, Brigadier MS Sebola, official members of the Division Crime Intelligence in the South African Police Service, Head Office, to attend the International Conference in Tokyo in Japan.

2. MOTIVATION

- 2.1 The National Police Agency of Japan is hosting the Twenty-sixth Asia Pacific Operational Drug Enforcement Conference on 30 January 2024 and 31 January 2024. Due to changes of the Head of Delegation SAPS: Major General NP Madondo's flight arrangements, which resulted in amendment of the financial implications of the officers. A revised document is forwarded to support the changes thereof.

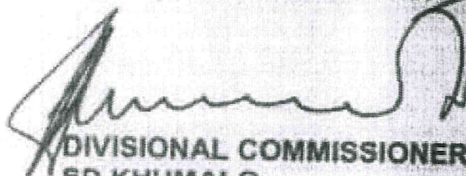
