
The Kalagadi CBE pricing as per the feasibility study carried out by MDM Engineering for Kalagadi Manganese for a new smelter at Coega was provided to Tubular (Mr. T Trindade) by Kalagadi (Aaron Maroeshe) as well as the allowable budget pricing in order to prepare the bidding document. This tender was awarded to Tubular.

5.

Katenge Tubular Construction tendered for:

Enquiry number **1084SMPP/10/2011AM/Kalagadi** which was awarded to Katenge Tubular Construction (Pty) Ltd (See Kalagadi Letter of Acceptance dated 28 September 2012)

Contract Number **KMM/TUBUL/SMPP/10/2012/GM/28/09**

Handwritten signature and initials, possibly 'AT' and 'SM', located in the bottom right corner of the page.

AJDC Trindade subsequently instructed Patrice Tiberi to prepare documentation for another Tubular entity (Tubular Chikuma JV) as he was not prepared for the BEE partner in KTC to benefit from this tender.


This decision was never disclosed to RMPS, the Katenge Construction BEE partners or even the KTC directors.



7.


Sishen South


provided the bidding prices of all other bidders to Tubular to revise their price to win the bid. Tubular put in a lower bid and was awarded the contract.

ESKOM


I am of the view that someone within Eskom Holdings SOC told TTC after the bid was adjudicated and that Tubular had to put in a bid just under R 120 million to get the bid for the Kusile Waste Water Treatment Plant. This tender was awarded to the Tubular Zamani JV as apparently KTC did not qualify as KTC was not level 4 BEE partner (See KTC BEE Certificate used in the Kalagadi contract)

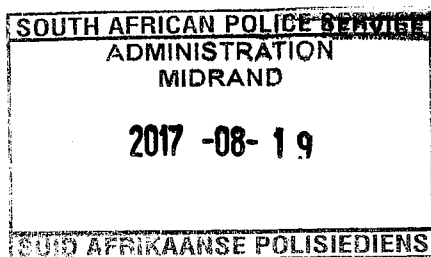
