The State v Arthur Fraser ROSEBANK CAS 72/11/2022

I hope you are well.

Herewith, a link to the docket I opened at Rosebank on Friday 2022-11-18.

The docket is currently with the branch commander, detective service at Rosebank, in copy. You would be aware that I have supplied a redacted copy of the docket to the media, merely to counter the lies and disinformation being peddled by Fraser and his many paid agent/journalists. Needless to say, the docket itself is NOT redacted in any way.

In view of today's judgement out of the Supreme Court of Appeal, a copy of which is attached, I wish to add a further charge of **Defeating the Ends of Justice** against Fraser, in that:

On or about 2021-09-05 Arthur Joseph Peter Fraser, unlawfully and intentionally, converted the custodial sentence of Zuma from prison to medical parole, despite knowing that he was NOT authorised to do so, and in so doing defeated the ends of justice AND brought the criminal justice system and Constitutional Court of South Africa into disrepute.

It may well be, that a case of '**Corruption**' has to also be investigated, as it may be found that Fraser 'owed' some or other 'duty' to Zuma, as a result of prior 'gratification' received by Fraser from Zuma, for example, the position/s he held and his access to state funds. By way of example, we all know that Zuma gave Fraser the keys to the secret services vault in September 2016, despite knowing that he was dishonest. We all knew that Mahlobo and Fraser were busy running a parallel intelligence service, under the guise of a so-called Principal Agent Network. Please advise if I need to make a further sworn statement to add to **Rosebank CAS 72/11/2022**, or if this e-mail will suffice, to expand the investigation into the very serious offences committed by Fraser in releasing Zuma from Prison.

It is in the interests of justice that Fraser is brought to justice very soon, as he is a festering sore on the democracy of South Africa and has been thumbing his nose at the good citizens of this country for far too long.

Put simply, Fraser walking the streets and thumbing his nose at the people of South Africa, is described by many as proof of the allegation that there is no rule of law in South Africa.

It's time to find some low-hanging fruit and scoop him up, so we can demonstrate that there IS a rule of law in South Africa after all.
